Superbike phenom Brandon Paasch visits San Manuel

Brandon Paasch rides professionally for Factory Vision Wheel, M4, Ecstar Suzuki in the Motoamerica Superbike Class. Some of his previous accomplishments include winning the 2021 and 2022 Daytona 200, finishing third in the 2020 Motoamerica SuperSport championship, 2019 British Moto3 champion, 2016 KTM RC Cup Championship, and he was the first American to race in the MotoGP Moto3 World. He also has the motorcycle track record at the Musselman Honda Circuit Track in Tucson for the Supermoto Asphalt Open Pro Class set previously.

He participated in, and decisively won, the 2024 AMA Supermoto Nationals Asphalt Open Pro Class. This event was held in Tucson the weekend of October 19th and 20th at the Musselman Honda Circuit Track in Tucson. He met local rider and racer Parrish Traweek at the event. He was

The county has a program that makes it easier to reach emergency services and get help fast.

Pinal County offers a program that provides emergency call devices for people who would like a way to contact emergency response personnel quickly and efficiently in the event of emergencies. The program provides a medical alert system, for anyone who wants one, that can be used for any kind of emergency.

The system is comprised of a 911 pendant that can be carried around the home and activated in the event of an emergency, and a base unit that will automatically dial 911 when a button on the pendant is pushed. The pendant has a microphone that allows the user to communicate verbally with a 911 dispatcher. Additionally, it operates on caller ID so that even if voice communication with the dispatcher cannot be established, emergency response personnel will automatically respond to the address of the caller.

The program has been operational for at least 20

Halloween is Almost Here!

It's that time of year when kids of all ages and sizes look forward to the fun of Halloween. What fun memories do you have about Halloween? Trick or treating? Carving the pumpkin? Dunking for apples at a party?

With the fun and activities of Halloween come some inherent dangers as well. According to the National Safety Council (NSC), kids love the magic of Halloween: Trickor-treating, classroom parties and trips to a neighborhood haunted house. But for moms and dads, often there is a fine line between Halloween fun and safety concerns, especially when it comes to road and pedestrian safety.

In 2017, 7,450 pedestrians died in traffic or non-traffic incidents, according to Injury Facts. Non-traffic incidents include those occurring on driveways, in parking lots or on private property. NSC research reveals almost 18% of these deaths occurred at road crossings or intersections. Lack of visibility because of low lighting at night also plays a factor in these deaths.

Here's a scary statistic: Children are <u>more than twice as likely</u> to be hit by a car and killed on Halloween than on any other day of the year. In 2017, <u>October ranked No. 2 in motor vehicle deaths</u> by month, with 3,700. July is No. 1, with 3,830 deaths.

So, what can parents do to keep their little goblins and ghouls safe? There are several things to keep in mind.

When talking costumes consider the following:

- All costumes, wigs and accessories should be fireresistant.
- · Avoid masks, which can obstruct vision.
- If children are allowed out after dark, fasten reflective tape to their costumes and bags, or give them a flashlight or glow sticks.
- When buying Halloween makeup, make sure it is nontoxic and always test it in a small area first.
- Remove all makeup before children go to bed to prevent skin and eye irritation.

If trick-or-treaters are out searching for goodies after dark or by themselves:

- A responsible adult should accompany young children on the neighborhood rounds.
- If your older children are going alone, plan and review a route acceptable to you.
- Agree on a specific time when children should return home.
- Instruct children to travel only in familiar, well-lit areas and stick with their friends.
- Tell your children not to eat any treats until they return home, and you have had a chance to inspect them.
- Children and adults are reminded to <u>put electronic</u> <u>devices down!</u> Keep heads up and walk, don't run, across the street.
- Give kids a flashlight or glow stick to help make them more visible at night.

If you are out driving on the roads, be a responsible motorist and be on the lookout for trick-or-treaters. Kids can get caught up in the excitement of the hunt for goodies and when least expected dart across the road. The National Safety Council (NSC) suggests these tips for drivers:

· Watch children walking on roadways, medians and curbs.

- Enter and exit driveways and alleys carefully. Always check behind your vehicle before coming out of a parking
- At twilight and later in the evening, watch for children in dark clothing. Kids should wear reflective costumes or clothing, but many do not so BE AWARE!
- Discourage new, inexperienced drivers from driving on Halloween.

Another area of safety you need to consider are the items you use to decorate your home. Here are some suggestions to help make your home more fire safe and possibly avoid a tragedy:

- Dried flowers, corn stalks and crepe paper can catch fire easily. If you use any of these items around your home make sure you keep them away from an open heat source like a candle, light bulb or heaters.
- Glowing jack-o-lanterns are a big part of Halloween decorations. Never use a lit, real candle inside a jack-o-lantern. The best and safest thing to use is a battery powered candle. They don't overheat and can't cause a fire to start if the jack-o-lantern gets toppled over.
- Keep exit doors clear of all decorations so any escape route isn't blocked.
- Make sure you test your smoke alarms to be sure they are in proper working order.

Local rider scores at the 2024 AMA Supermoto Nationals in Tucson

The journey for "making the podium" started about a year ago when Parrish Traweek and his wife Carla, went to the Supermoto Nationals held at Musselman Honda Circuit south of Tucson, Arizona in November of 2023 as spectators. The adventure came full circle in October of 2024 when Parrish took to the track himself in the Asphalt Amateur Class at the 2024 AMA Supermoto National Championship Series. There is more to tell of what happened in the year in between.

Parrish is not new to racing. He has a vast history of riding and racing in desert races and motocross across the West. He, like many in the area, grew up racing and riding in the deserts around San Manuel. His father and uncle had moved to the area from Texas in the 1960s to enjoy the warmth, jobs and open lands of Southern Arizona. The Texas brothers had their own affinities for riding motorcycles as fast as they would go. That love of speed and two wheels was passed on to Parrish and his sisters.

This love of motorcycles led to his desire to give Supermoto a try after being interested in it for years. His 20-year service to the U.S. Navy and U.S. Air Force may have kept him from pursuing a career in motorsports. The years did not lessen his desire for speed on a motorcycle. He found a new 2024 KTM SMR 450 in January 2024 to allow him to follow a new dream. This bike is designed to be "Ready to Race" right out of the Phoenix Storeroom floor. That was the closest one he could find as there are very few available and those that are available are sold fast.

The next approximately 10 months found Parrish and his unofficial pit crew, Carla Traweek, Joellen and T.C. Brown, testing and watching out for the bike and rider while getting both to their limits. The testing and riding started in local parking lots. It moved on quickly to track time at Musselman Honda Circuit in Tucson as we well as Phoenix Kart Rental Association track in Northern Phoenix. Many would be surprised to find out how much tire temperature, tire pressure, and fork pressure have to do with how fast a bike will go. Throw in a different sprocket, a blown fork, new brakes, multiple tire changes, and more to try and shave time off the clock. Added some help and knowledge from folks at Gear Shifters and 520 Moto Alliance in Tucson. Throughout the months, Parrish desired and believed that he could make the podium at the national level.

It was time for the 2024 AMA Supermoto Nationals. All of the energy, money and hours of practice led to the weekend of Oct. 19 and 20, 2024. With family, friends and fans cheering him on it was all down to Parrish and his drive to do his best. There was a total of six different classes covered at the international event, with riders from the United States and other countries in attendance. The Asphalt Open and Asphalt Amateurs were combined into one moto. A total of four motos were raced over the weekend for each class represented. Two motos were ran each day. Points were awarded based on the finishing place for each class moto. Each moto was either 15 or 20 minutes plus one lap. Starting positions were determined by qualification races held each morning. Every rider had a transponder which determined their fastest lap and their place at the starting line. Each race was started from standing still with the engine running.

Parrish's starting positions were pretty much middle of the pack. His ability to move up depended on solid starts and as much speed as he and his bike were able to muster. Most of the bikes were similar in make, model and power. It would come down to experience, multiple solid starts and the ability to move up and by others in his moto. Start results were mixed. The first starts of each day found Parrish further back in the pack then he wanted to be. He was able to move up as the motos went along. The starts in the second moto was better each day. Each found Parrish close to the front of the pack with less traffic to deal with.

Not surprisingly everything came down to the second moto on Sunday. Do well and have a chance to stand at the podium. Do poorly and go home with only experience to show. Parrish got an incredible start! He was fourth overall for the first several laps running right with the

Asphalt Open Pros. He did lose some time as the final race progressed but had an incredible run. He used all of his experience and energy to hang on to the end. After all the points were tallied, he placed a very hard-fought and well-deserved Second Place at the 2024 AMA Supermoto Nationals. Parrish achieved his dream of standing on the podium at the Supermoto National competition less than one year after stating his intention to do exactly that. It was an impressive accomplishment! His mother and sisters were in the stands watching him succeed.

years and, over the years, has successfully notified first responders of many people in distress in the Oracle area. The program in Oracle is administered by the Oracle Fire District for residents within the Fire District. The program was designed for elderly or handicapped people but is open to anyone who feels the need for an additional level of security within the home.

The units are provided free of charge by the county; there is no monthly service charge, and are installed and maintained by a team of Oracle Fire District volunteers. Routine checks, either in person or by phone, are made every six months to make sure the units are

working properly. Users are also trained in how to check their units by themselves.

In most cases, the units are functional anywhere within the home and, nominally, within 100 feet of the house outside. One limitation is that the user must have a local "896" land line. The County has investigated possible ways to provide this service using cell or mobile phones but, as of now, has not found a way to do so.
