Due to the resignation of Board Member Hector L. Apraricio, the Superior Unified District Governing Board has a vacancy which will be filled by Pinal County Superintendent of Schools Jill Broussard.

The successful candidate will be seated until Dec. 31, 2026.

BLM releases draft environmental assessment for Redhawk Copper

The Bureau of Land Management, Safford Field Office, released a draft environmental assessment for the proposed Copper Creek Exploration Project and the associated Mining Plan of Operations Nov. 7. The proposed project is located on BLM-managed public lands, approximately nine miles east of the Town of Mammoth in unincorporated Pinal County, Arizona. The release of the draft environmental assessment will start the 45-day comment that ends Dec. 22.

The applicant, Redhawk Copper, Inc. (Redhawk), submitted an application for a Mining Plan of Operations to the BLM SFO. If approved, Redhawk would be authorized to disturb up to 18 acres of BLM-managed public lands, which includes six acres for 67 drill pad sites and 12 acres for associated access roads. Before the



Local election results announced

Nov. 5 has come and gone, and the fury over voting for the next president of the United States was not the only issue on the ballot. Several propositions were on the ballot including home rule elections in Mammoth and a school override election in Ray. Superior had two contested school board seats up for election.

Voters across Pinal County voted to continue the half cent road maintenance tax. The tax has been in existence for 20 years and helps Pinal County and local municipalities fund basic road maintenance work. Proposition 486 was also known as the Pot Hole tax.

Voters in Mammoth had two major ballot items including voting for Mayor and the Home Rule proposition. Voters elected Ernest Bustamante for the position of Mayor. He won the seat with 231 votes. He ran against incumbent Mayor Patsy Armenta who received 179 votes. The Home Rule Option was approved 244 to

Ray Unified School district voters approved an override continuation: 741 voters approved the continuation, 504 voters voted against the measure. This was not a new tax but a continuation of the current override which allows the district to tax a bit more to allow for other general operations of the school. Without the approved continuation, the district would have needed to make major cuts to their budget.

The Superior Unified School district had two board vacancies up for election in the 2024 election. For the first time in several years, the open seats had multiple candidates seeking election to the board. Ericka Vasquez who was appointed to the board several years ago opted to run for the four-year term, vacated by Nathan Duarte. Nick Cruz a local businessman ran against Vasquez for the four-year term. He won the seat with 766 votes to Vasquez' 454 votes. Two new candidates sought election to the two-year term. Randi Villegas challenged Martin Navarrette for the term. Navarrette won the seat with 746 votes versus Villegas 461 votes. Superior Unified School District will have an additional seat open for appointment due to the recent resignation of Board President Hector Apparicio.

These results were gathered from the Pinal County Elections office.

Early morning fire in San Manuel

San Manuel Fire Department responded to a housefire in the 100 block of W. Fifth Ave., San Manuel, early Wednesday morning.

The department was dispatched on Nov. 6 at approximately 1 a.m. Upon arrival, firefighters found the home to be fully engulfed in fire. The home's owner was observed being attended by AMR ambulance personnel.

According to Ernest Ivy, Assistant Chief, "The fire was determined to be a defensive exterior attack. Two quick attack fire hose lines was deployed to the front and rear of the house. The initial fire was knocked down. Overhaul operations were started to extinguish deep seated smoldering fires."

Ivy reported that the fire was extinguished at 5:36 a.m. and that the fire appeared to have started in a rear enclosed porch area.

Oracle Fire Department assisted with extinguishing the fire.

Arizona Forestry visits San Manuel to discuss wildfires and Firewise

Corey Guerin, Lead Prevention Officer, with the Arizona Department of Forestry & Fire Management met with members of the community at the San Manuel Community Center on Wednesday, Oct. 23, 2024. Frank Molina from BHP and Ernie Ivy from San Manuel Fire were also in attendance to answer questions and discuss fire concerns around the community.

Corey gave an insightful presentation about wildfire dangers, risk assessment, and the benefits of having a community Firewise program in place before wildfires happen. He also discussed community specific concerns. He indicated that he would be very willing to assist in setting up a Firewise community in San Manuel if there was enough interest. He expressed his willingness to return to answer more questions and present additional information to more of the community. He also discussed the importance of being signed up for the Pinal County Emergency Notification System (PENS).

Molina discussed ongoing concerns for fire ignition risk in and around BHP property and throughout the community. It was pointed out that several areas have been recently cleared in the community with more to follow. It was also pointed out that there are large areas owned by BHP that are being used to dump trash and other flammable material with negative effects to the long-term concerns of fire abatement.

Ivy discussed established and planned mutual aid agreements with local, state and federal agencies that would assist San Manuel in the case of a fire. He also discussed planned future training for solar-related fires in reference to the planned solar farm and the multiple homes in the community that have solar panels already installed. He also discussed future enlarging of the San Manuel Fire District.

Several members of the San Manuel Revitalization Coalition (SMRC) were on hand. The group expressed an interest in pursuing Firewise USA site designation for the San Manuel community. Firewise community members may be able to find reduced insurance costs, as well as other benefits. There would have to be enough on-going community participation for this idea to come to fruition, but it is certainly a possibility. Interested San Manuel community members can contact SMRC directly to express interest and sign up to be notified of updates. All in attendance appreciated the time and answers presented.

Firewise Recognition Steps:

- Obtain a Community Wildlife Risk Assessment.
- Form a Community Board/Committee.
- · Create an Action Plan.
- Conduct a "Firewise Day" event.
- Invest the Equivalent of the National Hourly Volunteer Rate per Dwelling Unit, Annually.

PENS stands for Pinal Emergency Notification System. It is Pinal County's tool to notify residents of any impending or current emergency where action by residents may be necessary. PENS utilizes the Genasys Emergency Management software.

A PENS alert notifies residents when an emergency is immediately impacting their community, and they may need to take action. These notifications are usually reserved for more severe situations where life or property may be threatened. They can also be used in situations such as a weather alert or wildfire, where time is of the essence, and immediate notification is imperative.

Alerts are issued through phone, text, and/or email, depending on how you registered to receive your alerts. PENS can also be indirectly posted to County or departmental social media channels and can be sent according to any geographic boundaries necessary or be used as a countywide message blast."

Some of the topics discussed are summarized below.

"Reduce Home Ignition Risks

When considering your home's "ignition risk," it can be helpful to think about the area around your home, or "home ignition zone." This includes your home at the center and everything within 100 feet (or 30 meters).

A home's ignition risk is determined by its immediate surroundings and the materials used for its construction. The specific location isn't necessarily as influential

as the landscape around it.

HOME IGNITION ZONES (HIZ) CAN BE DIVIDED INTO 4 PARTS:

"HOME ZONE"

The home itself and everything within 5 feet of the foundation. Includes: Fences, decks, porches, and other attachments. measures: Keep lawns mowed and well-maintained; well-spaced plantings of low flammability species; swap mulch for rocks, gravel, or stone; remove large fuel packages like firewood piles from this area.

30-100 FEET

Preventative measures: Keep irrigated with lowgrowing and low- flammable plants; create separation between grasses, shrubs, and trees to avoid fire spreading into taller vegetation in a "fuel ladder" effect; space trees to prevent crowns from touching.

100+ FEET

Research shows that keeping high intensity fire 100 feet from a home will prevent the fire from igniting the home directly. Preventative measures: Place low-growing plants and well-spaced trees; keep volume of vegetation (fuel) low.

CHECKLIST

Research shows taking simple, scientifically proven steps can help reduce the risk of your home and property becoming fuel for a wildfire. Band together with homeowners in your community to follow this list of actions throughout the year.

Clear — ignitable material such as needles and leaves from roof, gutters, eaves, porches and decks. Repair — any loose or missing roof shingles/tiles and caulk any gaps or openings on roof edges.

Cover — exterior attic vents and install metal wire mesh (1/8 inch or smaller) to under-eave and soffit vents.

Relocate — items kept under decks or porches; swap out vegetation in these areas for rock or gravel.

Replace — mulch with hardscaping, including rock, gravel or stone.

Remove — ignitable features within 30 feet of all structures including firewood piles, portable propane tanks and dry and dead vegetation.

Protect — water dry grass and shrubs, trim brown vegetation and dispose of yard waste.

Prune — low hanging branches (6-10 feet for taller trees, 1/3 of tree height for smaller trees); remove any tall grasses, vines and shrubs from under trees.


