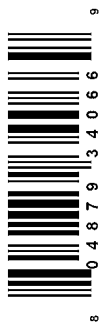

# Boyce Thompson Arboretum to welcome furry friends and their owners for the Tails & Trails Event on Saturday, Jan. 10

Dog parents and outdoor enthusiasts alike are invited to head to Boyce Thompson Arboretum on Saturday, Jan. 10, 2026, for a fun and festive event designed with furry friends in mind.

Tails & Trails will take place from 10 a.m. to 3 p.m. at the Arboretum, 37615 E. Arboretum Way, Superior. Both two- and four-legged visitors can attend the event for free with the pet parent's paid admission; additional items and activities are available for purchase.

Activities during the event will include:

- Adoptions with PCACC and Barb's Dog Rescue
- Docent-led dog hikes
- Pet related vendors
- Food and beverage trucks

Puppy Yoga classes will also be held from 9 a.m. to 10 a.m. and from 10:30 a.m. to 11:30 a.m. Instructor Deb McClarnon will lead the guided yoga classes that feature free roaming puppies. The all-levels yoga classes, held in the lobby of the historic Smith Greenhouses, will demonstrate how to mindfully move through gentle postures with breath awareness to promote relaxation, flexibility, and circulatory health. Leashed and well-behaved pets are welcome to attend Tails & Trails. Pets must be on a leash no longer than six feet and under the physical control of the owner. Pet owners are responsible for cleanup while they are at the Arboretum.

Pet parents should bring cash to the event, as internet and cell service are limited around the garden and vendors may be unable to complete transactions via a point-of-sale system. Because the majority of the trails consist of uneven and unpaved hard-packed dirt, people are encouraged to wear appropriate footwear.

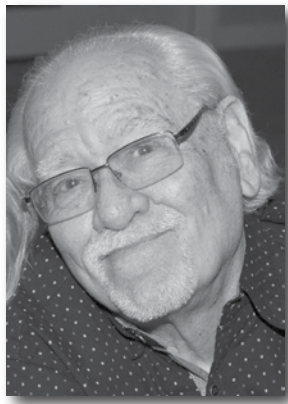

For 150 years, the people of Superior built this town with their bare hands.

Our rural community was carved from the Superstition Mountains like the silver and copper mines that dot this area – an indelible link to

both our past and future.

Now, as Superior experiences an economic resurgence brought about by industries old and new, our town continues to envision and chart its own path. This time, with energy.

Like water, access to reliable and affordable energy is essential to every Arizona community. Superior is growing. We remain a small town of roughly 2,500 residents, but our downtown district is buzzing. A new generation of travelers and tourists is

discovering Superior and our unique shops, restaurants and beautiful natural surroundings - all less than an hour from metro Phoenix.

Mining is also a big part of our story, of course. Resolution Copper is prepared to create thousands of local jobs as it pulls enough copper out of the ground to supply an estimated 25% of North America's copper demand. We are working hard to keenly target the development of affordable housing and recruitment of quality employers so there are more places to live and work for Superior families.

None of this is possible without affordable, reliable power.

To help provide the energy Superior needs to thrive, we have proposed to SRP a local parcel for construction of a Battery Electric Storage System (BESS). The facility, when completed, will be capable of producing 100-150 MW for four hours at a time - enough to power over 25,000 homes during peak demand

on summer evenings. This energy will not only support Superior but the surrounding areas that are growing in the East Valley and Copper Corridor.

The beauty of a battery storage system like this is it can be charged when demand is low (and power is less expensive) and utilized when demand and energy costs are high. That improves reliability and saves money on the power homes and businesses need.

Arizona has nearly 3,900 MW of operational battery storage statewide, with plans

to nearly double this portfolio by 2026. Already, Arizona is among the Top 3 states in the nation in terms of deployed, utility-scale battery storage.

For the Town of Superior, battery storage means emission-free energy, construction jobs and millions of dollars in lease revenue over the life of the project. But SRP's broader network of customers will also benefit since the battery power is more than enough for Superior's current needs and will flow to the grid.

The need for more energy in

our state is growing. Arizona's major utilities - SRP, APS and Tucson Electric Power - all broke records this past summer for peak demand.

Energy consumption is forecast to only keep climbing as our state grows and the economy requires more energy for manufacturing, data processing and other key industries. Rural Arizona must look at these energy opportunities, not only to serve its own residents but also to be actively engaged and leading to ensure the

# Gold Bond Winkelman Quarry Plant marks centennial celebration

The Gold Bond Winkelman Quarry Plant in Dudleyville recently celebrated its centennial. Gold Bond Building Products is affiliated with National Gypsum Company, headquartered in Charlotte, NC.

National Gypsum traces its roots to the collapse of Beaver Manufacturing Company, a producer of Beaverboard wood fiberboard. After their former employer folded, three colleagues — Joseph L. Haggerty, Clarence E. Williams, and Melvin H. Baker — teamed up to launch a new venture in 1925.

Haggerty experimented in his kitchen to create a lighter, stronger gypsum board. Baker, known for his marketing expertise, sold stock to fund the company. While Haggerty's inventive work and Baker's salesmanship are well documented, Williams's contributions remain less clear, though he was instrumental in the company's founding.

Within 10 months, National Gypsum was producing "National Mineral Board," rolling out of its first plant as Baker's team began their sales push.

Though the company grew quickly, it later faced bankruptcy and legal challenges. In 1993, it reorganized with eight mines, 24 manufacturing facilities, and a new parent, New NGC, Inc. Two years later, C.D. Spangler purchased the company. He served as chairman until 2000 and remained on the board until 2018. Tom Nelson then became Chairman, President, and CEO, a role he has held for more than 20 years.

Today, National Gypsum markets high-performance building products under the names PermaBASE, Gold Bond, and ProForm.

The Winkelman Quarry began mining gypsum in the early 1980s and now employs about 22 workers, most operating heavy equipment to strip gypsum rock. With the highest strip reserves among company quarries, Winkelman consistently leads in production. The Eloy Gold Bond Wallboard Plant near Phoenix is the largest and most sustainable in the network, spanning the equivalent of 10 football fields. There, gypsum from Winkelman is manufactured into wallboard.

Gina Laughlin, Plant Office Manager and lifelong Winkelman resident, reflected on the plant's impact:

"I have lived in Winkelman all my life, am so proud of my small town, and honored to contribute to Gold Bond Building Products where community and hard work go hand

in hand. Who knew these mountains held gypsum of such remarkable quality—fueling industries far beyond our town? La Posada in Tucson, the Omni Hotel in Tempe, and the new Foothills Mall in Tucson were built strictly using gypsum from our Gold Bond Plant here in Dudleyville."
