Citizen Science and Conservation

The Southeast Pinal County Master Gardeners are pleased to invite you to our Community Education February event.

“How Your Citizen Science Data Helps Conservation” will be presented by Dr. Katy Prudic, PhD, Assistant Professor in the School of Natural Resources and the Environment, University of Arizona, on Feb. 14, 2024, as a free ZOOM presentation.

Many of us participate in citizen, or community, science programs such as eBird, iNaturalist, Nature’s Notebook and eButterfly. Whether we are collecting or cataloging information on butterfly migration, bird counts or plant disease patterns and infestations, our observations do matter. How that data is cleaned, stored, shared and used for conservation action is a black box for most citizen scientists. This data is important for evaluating species of concern, predicting the impacts of climate change, targeting habitat enrichment, and training the next generation of scientists and conservationists. Professor Prudic will discuss the general pathways your animal or plant observations help spur conservation action while also providing examples from the desert southwest.

Dr. Prudic has been involved with the creation of software applications and programs for citizen scientists and the use of that information. Her findings have been published in Science, Proceedings of the National Academy, and Proceedings of the Royal Society and featured on BBC, National Geographic, and the New York Times among others.

Essential Functions:

- Determines community needs and desires
- Develops/promotes community interest in recreational programs/activities
- Coordinates recreational programs and activities with other public and private agencies
- Interacts with public and private agencies and individuals to solicit funds for program activities
- Conducts classes, workshops, meetings, clubs and special events; coordinates recreational programs with service agencies within the community

Requirements:

Must have knowledge of recreational, cultural and social needs of the community; recreation program and activity planning techniques; and purchasing and supervisory principles and practices. Must be skilled in making recreation program decisions; analyzing, interpreting and reporting research findings; selecting and developing recreational activities suitable for individual and group interest; and establishing and maintaining effective relationships with the public and members of Town staff.

Physical Requirements and Work Environment:

There is a need to stand, stoop, walk, lift light to moderate objects (up to 50 pounds) and perform other similar actions during the course of the work day. The Town of Superior promotes a drug/alcohol free work environment through the use of mandatory pre-employment drug testing.

Minimum Qualifications:

A 4-year degree in related field preferred and a minimum of two (2) years' experience in recreational activities or any equivalent combination of experience, education and training which provides the knowledge, skills and abilities to do the job. Must possess a valid Arizona Driver's License.
