## LETTER TO THE EDTIOR

# Protect the Lower San Pedro River Valley

was born in Superior, Arizona (the only baby in the Magma Hospital nursery on that September morning) and spent my first nine years in Superior and San Manuel. Dad worked for the Magma copper mine. His lifetime of working in mines – copper, oil shale, coal and even diamonds – supported my family and paid for much of my college education.

I have deep respect and appreciation for the mining process and, more importantly, the people that make it work. My favorite childhood memories were formed while exploring the amazing landscapes around Superior and the Lower San Pedro Valley with Dad at the wheel of our old CJ7. Many weekend mornings began with a call and a plan to find water in the desert. They often ended with Dad, Sister, the dog, and me dirty, exhausted and full of stories of the wildlife and geological wonders we encountered — and keen to get back out for more.

Dad followed mining jobs to Colorado, Wyoming, Alaska, Yellow Knife, Canada, Chile, Argentina and more. But he always itched to get back to his favored area, Southern Arizona. He instilled in me a love and appreciation for this place. From the highest mountains to the lowest washes and all the hidden treasures inbetween.

The Lower San Pedro River Valley is precious, not only for the memories I hold, but for its ecological significance for its wild and human inhabitants. There is literally nowhere like this place in the world. AND IT IS IN GRAVE DANGER OF BEING DESTROYED.

If the proposed mining operations are allowed in the Lower San Pedro River Valley, the plants, animals and people of this special region will be subjected to toxic pollutants and the literal raping and scraping of one of the world's most unique and fruitful natural areas. I haven't forgotten, either, the rancid sulfur taste when the San Manuel Smelter would belch a wicked fog that had our moms gathering kids from yards and streets to shelter indoors. Nor can I unbreak my heart from seeing pools of unearthly green goo seeped from exploration and tailings sites that decimated life for yards around them.

Yes, new mines will bring some jobs to the area. But it won't be like it was in the region's heyday. The vast majority of the money made from the proposed 28 square miles of open-pit mines, block-cave mines, and exploratory drill sites goes to out of state and foreign investors. Additionally, there is much more automation, now – translation: fewer jobs for real people. See, these companies know how to do better, but they don't. They only "do better" if it improves their bottom line. The health, wealth and well-being of the area and its inhabitants aren't part of that bottom line. We are a liability.

Lastly, beyond the toxic waste and tailings let's talk about OUR bottom line: water. These operators plan to drain an estimated 175,000 gallons of water per month from the water table (according to a BLM hydrologist) once operations are up and running. That's 2.1 million gallons a year. How will that once clean and pure water be replaced? It won't be. What will the tainted water carry with it back into the water table from which we drink and bathe? The foreign mining companies think you don't want to know - you probably don't, frankly. And these operators aren't interested in telling us the exact nature of the true damage they will do or saving us from the longterm, possibly catastrophic effects. Clean water is a finite, precious resource.

It is clear from the Decree that the Court intended that Respondent receive the percentage of the value of the benefits at the time of the Decree as the Decree states: THE COURT FINDS that the above, Wife is entitled the real and personal property, under the circumstances set forth above, Wife is entitled to an offset based upon the below analysis: Timeshare Offset: \$7450.00; Business Interest: 725.00 Motor Vehicles: 8,975.00 Total: \$17,150.00 Husband's share of ASRS Interest: 725.00 Motor Vehicles: 8,975.00 Total: \$17,150.00 Husband's share of ASRS plan: \$31,411.50 Amount Wife owes Husband after deduction of offset from Husband's ASRS plan share: \$14,261.50 This amount represents 22.701 % of the balance of Wife's ASRS retirement plan as of the date of service (\$62,823.00 x 22.701 % = \$14,261.45). Therefore, Husband should receive 22.701 % of the community share of Wife's ASRS retirement plan calculated on the basis of the coverture fraction formula, rather than 50% of the community share on the basis of the said formula. Emphasis added. 4. Based on this computation, Respondent's share of the pension would be approximately \$14,260.00. 5. Because of the language in the Decree, the form QDRO prepared by Petitioner without counsel inserted the percentage determined by the Court without specifying that the percentage was to be based on the value of the pension as of the date of service. Thus, the language is help interpreted to award Respondent 22.701% specing that the percentage was to be based on the value of the person as of the date of service. Thus, the language is being interpreted to award Respondent 22.701% of the current value of the pension, that being approximately \$242,000. This QDRO was filed on June 13, 2018. 6. The Hive at the Superior Enterprise Center is the first HIVE in Rural Arizona. Superior joins a family of Hives in Guadalupe, Tempe and Phoenix. Superior's HIVE features a telemedicine room, podcasting room, 3-D printers, MAC Computers, iPads and is fully finished with comfortable furniture for all activities including socialization and remote working spaces.

Executive Director for IDIA Erin Carr-Jordan remarked, "Superior was the right choice for IDIA's first rural Hive because it has the right mix of need, opportunity, and community readiness. The town has been actively working to revitalize its economy, and access to technology and digital skills is a critical piece of that. There's strong local leadership, a willingness to collaborate, and a clear gap that IDIA and the Hive can help fill."

It's also a place where IDIA can learn what works in a rural setting — what's different, what stays the same, and how to adapt the model to ensure it makes sense for the people who live there. Superior

isn't just a pilot location; it's a proving ground for how this kind of initiative can scale in other rural communities. As the Town of Superior develops the multigen center at the original Superior High School, job training and entrepreneurial development and education programing is at the forefront of the development of the multi-gen.

Mayor Mila Besich in her remarks during the ceremony thanked Rebuild Superior Inc. and the Superior Enterprise Center for their leadership and dedication to supporting this initiative with IDIA. She also spoke of the power of the Superior network along with the Flinn Brown Network for connecting the Town with IDIA. She thanked Public Works for working on a tight timeframe to complete the work needed for the opening and explained that the remodeling work was completed with funds from Resolution Copper through the Regional Economic Development Agreement that the Town has with the mining company.

The Hive has full time staff that can assist participants with their personal tech needs, weekly classes training and can also support anyone who just wants to learn more about technology. There is no cost to using the HIVE and it is open Mondays noon to 6 p.m., Tuesdays 10 a.m. to 4 p.m., Wednesdays noon to 6 p.m., Thursdays noon to 6 p.m., Fridays 10 a.m. to 6 p.m. and the first and third Saturdays 10 a.m. to 2 p.m.
