# Threats to the Lower San Pedro Valley (Watershed)

read T. C. Brown's article about the Feb. 11 meeting hosted by the local group, Lower San Pedro Watershed Alliance (LSPWA). I was pleased that he mostly presented an unbiased account of the meeting and that he encouraged people to personally research the content presented at the meeting.

I was very disappointed that, in his closing comments, he choose to cite a Gov.tech Emergency Management Blog article about NIMBYs and BANANAS. Selecting this article is a disservice to the significant contribution of this organization to reality based Emergency Management. It's like picking one word from a book to

represent its overall message and purpose.

To those who don't know, NIMBY stands for "Not In My Backyard." BANANA, apparently is a new moniker for "Build Absolutely Nothing Anywhere Near Anyone." These are phrases most commonly used by narrow economic interests to characterize people opposed to them. In reality, these are people who are concerned about protecting and sustaining a healthy community, yet they are branded as "extremists."

I strive daily to make Oracle a safe, healthy and economically sustainable community. I am a member of several local groups to achieve those goals. I guess that makes me and those I collaborate with "extremists."

I empathize with my friends and residents in Mammoth and San Manuel who strive to make their communities safe, healthy and economically viable. I guess that also makes them "extremists."

It's easy for someone who is uninformed/misinformed or not facing the threats in their own backyard to toss NIMBY stones. If they faced the potential threats their neighbors do - dry wells, contaminated water, hazardous air quality, decreased property values and possibly unsellable property - they would be offended by being called NIMBY extremists.

We can do better than this. We can treat our neighbors with respect and strive to collectively find the truth.

While I support the need for extraction projects, there is a right place and wrong place for such projects. It is my belief that there is not, nor will there be enough water to support the mining activity and our communities as proposed by the Redhawk investors.

The Redhawk investors may be on legal grounds using

outdated water and mining laws to pursue their economic interests, but that does not morally or ethically justify their activities. They have made a grossly misguided investment based on an over optimistic assessment of their economic opportunity. Proposed economic benefits to a small group of people must be weighed against the impact on our communities and ecological resources.

According to Redhawk's own published reports, any claims about environmental impact and economic benefits are "speculative."

Wrapping and marketing the investment project in terms of patriotism, national security, extreme need for copper and economic benefits does not change the threat to the safety, health and economic viability of our communities.

Those in Mammoth and San Manuel who will live closest to toxic tailings and a water-guzzling hole in the ground will experience as in past years, air, water and light pollution. They'll hear a mine that's running 24/7 and experience the nonstop semi-traffic.

Let's have the courage to work together to protect our communities and save this unique place of extensive ecological resources. After all, it is our home ... where we should be safe and healthy!

# BLM opens comment period on proposed mining exploration near Mammoth

SAFFORD, Ariz. – The Bureau of Land Management is seeking public input on a draft environmental assessment for the proposed Copper Creek Exploration Project on public lands near Mammoth in Pinal County.

If approved, Redhawk Copper, Inc., would be authorized to modify 18 acres of public lands, including six acres to construct 67 drill pad sites and 12 acres for associated access roads. The company would eventually return 14 of the modified acres to their original state. The remaining four acres would be for widening existing roads open to the public for recreation and other activities. Any future plans to mine as a result of this exploration would include further analysis and opportunities for additional public review and

# Kelly, Gallego introduce bill to pave way for Gila County Veterans Center

Last week, Arizona Senators Mark Kelly and Ruben Gallego reintroduced legislation to transfer the Pleasant Valley Ranger District Administrative Site to Gila County, paving the way for the development of a veterans retreat and community center to support the nearly 5,500 military veterans who call the county home.

The bill directs the U.S. Forest Service to transfer 232.9 acres of underutilized National Forest land near Young, Arizona to Gila County. Once transferred, the site will be transformed into a dedicated space for veterans and their families to gather for retreats, meetings, and community events. The center will also serve as a mobile VA clinic site, expanding access to critical health care services for veterans in rural Arizona.

"For too long, this land has been sitting idle when it could be put to use supporting the veterans who made immense sacrifices for our country," said Kelly. "By transferring this land to Gila County, we're ensuring veterans, and their families have a space to gather, connect, and access health care closer to home."

"Having a place to gather with fellow veterans, connect with nature, and access services is vital to veterans' well-being," said Gallego. "I'm proud to introduce this

It is clear from the Decree that the Court intended that Respondent receive the percentage of the value of the benefits at the time of the Decree as the Decree states: THE COURT FINDS that the above, Wife is entitled the real and personal property, under the circumstances set forth above, Wife is entitled to an offset based upon the below analysis: Timeshare Offset: \$7450.00; Business Interest: 725.00 Motor Vehicles: 8,975.00 Total: \$17,150.00 Husband's share of ASRS Interest: 725.00 Motor Vehicles: 8,975.00 Total: \$17,150.00 Husband's share of ASRS plan: \$31,411.50 Amount Wife owes Husband after deduction of offset from Husband's ASRS plan share: \$14,261.50 This amount represents 22.701 % of the balance of Wife's ASRS retirement plan as of the date of service (\$62,823.00 x 22.701 % = \$14,261.45). Therefore, Husband should receive 22.701 % of the community share of Wife's ASRS retirement plan calculated on the basis of the coverture fraction formula, rather than 50% of the community share on the basis of the said formula. Emphasis added. 4. Based on this computation, Respondent's share of the pension would be approximately \$14,260.00. 5. Because of the language in the Decree, the form QDRO prepared by Petitioner without counsel inserted the percentage determined by the Court without specifying that the percentage was to be based on the value of the pension as of the date of service. Thus, the language is help interpreted to award Respondent 22.701% specing that the percentage was to be based on the value of the person as of the date of service. Thus, the language is being interpreted to award Respondent 22.701% of the current value of the pension, that being approximately \$242,000. This QDRO was filed on June 13, 2018. 6. Petitioner did not realize the problem with the Decree of Dissolution and QDRO until just recently, when she retired and the ASRS was set to be divided. 7. Although the Court referenced the coverture fraction formula in its Decree, divided .7. Although the Court referenced the coverture fraction formula in its Decree, the QDRO issued did not structure Respondent's interest in Petitioner's plan in terms of the formula. # Ray Unified School District: New Leadership Renewed Focus

**By Mila Besich** Copper Area News

The Ray Unified School District is currently and actively implementing a new and refreshed mission and vision for the school district. During their December 2024 board meeting, the Ray Unified School Governing Board approved the hiring of Dr. Jeremi Brewer as the part time superintendent. The vote to hire Dr. Brewer was not unanimous and was a four-to-one vote.

Despite the lack of unanimous board approval, Dr. Brewer has begun developing and implementing a transformational leadership dynamic, working together with the Junior-Senior High School Principal Patti Edgemon and Elementary Principal Melissa Huerta. The district's leadership team has set several strategic goals for the district. One primary change is adjusting the curriculum to a mastery- and project-based educational model. Mastery-based educational models allows the students to study the subject material and only move forward when they master the learning objective. With the project-based modeling, teachers can teach each skill set with a project in mind, often combining math, English and science into each project to allow for subject mastery. This type of educational curriculum design can allow for more robust skill mastery and immersive skill utilization across the curriculum.

A model such as this allows the district to

align all courses from Pre-K through 12 adding in opportunity to learn the basics such as English Language Arts, Math and Science through project-based learning. This especially becomes more of a career growth opportunity for students as they enter junior high and high school. The plan for the upper grades will allow students to pick their coursework based on career exploration.

Those students in grades 9-12 will be able to pick from the following career objectives, agriculture, child development, stage craft (theatre arts), sports medicine, and industrial arts. The industrial arts portion of the curriculum will include programs in welding, shop and auto. Dr. Jeremi Brewer shared that already the district has received an great deal of support from Resolution Copper including financial and in-kind support for the career technical programs they are advancing at RUSD

Junior-Senior Principal Patti Edgemon commented that students are already showing a positive response to the leadership changes.

"They are excited to come to school and all seem to be interacting more with each other," she said.

She also credited some of the improved camaraderie amongst students due to the fact that they are now a cell phone free campus.

"The students really are interacting more," she said.

returned after serving as a Dean of Students at the Florence Unified Public School.

Elementary School principal, Melissa Huerta shared that with the new curriculum alignment, students at the Elementary school will now have music, art and physical education in addition to the core competency programs such as Math, English Language Arts (ELA) and Social Studies.

"I am very excited for the new opportunities for our school," she said.

After a year serving as the elementary principal, she has enjoyed having the opportunity to work with all of the students and families as RUSD.

Dr. Brewer explained that the long term vision for the school is to include the community more and have the students engaged across the community in their studies. Under his leadership they have set a five-year goal to be an "A Rated" school, have increased school pride and have 800 students in the school district. While population may be declining in the greater Copper Corridor region, their goal is to add an online school component which would allow students statewide to participate in the RUSD curriculum model. To accomplish this goal the district leadership has adopted a mission of "Develop Leaders. Inspire Innovators. Foster Curiosity". To inspire the mission, the values of the entire team and students will be based on collaboration, mastery-based learning, project based learning and community engagement.

He further explained that to accomplish all of this the school leadership will have a management promise.

"That promise is compassion, accountability and transparency," he explained. This mission and vision and management promise is what will guide the district to reach their year 2030 goals. When the online school component is

added to the district curriculum, the school will receive 80 percent of daily attendance revenue per student, which will increase the revenue for the district.

Recently the RUSD Governing Board approved a \$3 contract with Dr. Brewer's wife, Dr. Rebecca Brewer. Her scope of work is to review the current curriculum and help to develop the long term strategic curriculum. Currently Dr. Rebecca Brewer operates the Winkelman Preparatory academy and is highly skilled and trained in curriculum development and management. She offered the discounted rate on her services as a service to the school to help the board and staff have a plan for the new curriculum design and ensure that it continues to meet the state standard. Dr. Jeremi Brewer explained that his wife Dr. Rebecca Brewer would be reporting to the Junior-Senior High Principal Patti Edgemon. Should the board decide to hire her after her

initial study, she will continue to report to Principal Edgemon.

"We have consulted with Judge Orzell on this matter to ensure we do not violate any policies on nepotism," explained Dr. Brewer.

The energy of these three educational leaders was fully observed during their interview, a willingness to make changes to benefit the students and families in the district. Dr. Brewer further explained that the community should be aware if his wife is hired by the district after her initial contract to develop the curriculum alignment, she will be closing the Winkelman Preparatory. Dr. Brewer explained that he and his wife are both committed to the education systems within the community and want to share their knowledge of curriculum development and education in the region.

"If this all comes together, our children will be attending public school for the first time next year," he explained.
