

# Federal deadline for air travel identification begins next month; Arizona Travel ID will get you through airport security after May 7

There is less than one month before the federal deadline for domestic airline travelers to have a federally compliant form of identification. If you plan to use your driver license or state-issued ID card for air travel this summer, now is a good time to visit an Arizona Department of Transportation Motor Vehicle Division office or selected authorized third-party locations to get your Arizona Travel ID. Without the Arizona Travel ID or other

form of federally compliant identification such as a valid U.S. passport, you'll risk missing an airline flight.

The gold star in the upper right corner of an Arizona Travel ID shows that the holder has met federal standards requiring extra documentation. This includes:

· Proof of identity: a birth certificate or

# Four-day natural resource camp offered for grades 8-12

High schoolers who enjoy nature or are considering careers in natural resources conservation – apply soon. Don't miss your change to be among a select 35 campers invited to spend July 7-11 at cabins in the Prescott National Forest, during a week-long residential camp focusing on water, soils, plants and wildlife. Days include hands-on experiments, outdoor projects, and engaging activities. This workshop focuses on the basics of natural resource management, empowering youth with knowledge and practical techniques to help conserve our environment. It's not "all work and no play" either, in between learning sessions, organizers plan recreational activities such as fishing, hiking, swimming, volleyball and horseshoes. Tuition for the week includes meals and lodging for \$150 per student. No substantial nart of the benefit of or be distributable to its directors, officers, members, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article II hereof. No substantial part of the corporation's activities shall be the carrying on of propaganda or otherwise attempting to influence legislation. The corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. It is intended that this corporation shall have the status of a corporation that is exempt from dederal income taxation under Section 501(a) of the Code as an organization described in Section 501(c)(3) and is other than a private foundation by reason of being described in Section 509(a)(1) or (2) of the Code. During any period that the corporation is classified as a private foundation as that term is defined to Section 500 of the Code to which are deductible for estate tax purposes under Section 2055(a)(2) of the Code or corresponding provisions of any future federal tax laws; and/or (4) gifts to which are deductible for gift tax purposes under Section 2522(a)(2) of the Code or corresponding provision of any future federal tax laws. 


