# Dry conditions statewide could fuel high fire activity across Arizona

Late last month, Arizona Department of Forestry and Fire Management (DFFM) along with local and federal partners briefed Governor Katie Hobbs on the outlook for Arizona's upcoming fire season. Unlike year's past, state and regional fire behavior analysts warn this year, Arizona's lingering warm and dry conditions, coupled with drought-stricken fuel could be the driving forces for widespread fire activity. In addition, a windier spring weather pattern and sustained warm and dry conditions could potentially lead to larger and longer

duration fires sooner, particularly in southeastern Arizona, including within Cochise County. Then, as the state moves into its hot and dry summer months, analysts forecast fire activity increasing throughout Arizona, including across the high country. The minimal moisture in Flagstaff and in northeastern Arizona also puts those areas at higher risk for increased fire activity.

DFFM's State Fire Management Officer John Truett said this year's season is not based on elevation or fuel type. "More than half of the state is in extreme drought status. That combined with a lackluster winter and spring, in terms of rain and snow, have really put us at a disadvantage statewide."

However, the possibility is there for areas south of the Mogollon Rim, including across the Sonoran Desert landscape, and southern Arizona to see larger intensity fires due to the fuel types and amount of fuel loading. Prior to the recent precipitation, state fire personnel recorded historically low live fuel moisture levels within brush in Yavapai County and in southeastern Arizona in Bisbee and Douglas. The abnormally low moisture levels essentially equate to dead fuel that can be highly conducive to quick ignitions and rapid- spreading fire.

"The recent moisture may have spared us a few weeks in terms of keeping fire activity down. However, with the possibility of a very active fire season across Arizona, it is important that residents stay vigilant of the conditions. Be prepared and be proactive when it comes to fire. Do your due diligence when working outdoors with tools that may spark. Be a good steward of our lands and recreate responsibly. It's not a matter of if a fire starts, but when," Chief Truett said.

In 2024, firefighters responded to 2,162 fires – an increase of 33% from 2023. Those 2,162 fires burned 282,507 acres of private, state, and federal lands. In 2023, 1,831 fires burned approximately 188,000 acres.

Just last week, firefighters scrambled to extinguish a series of wildfires along Highway 79 between Oracle Junction and Florence. Those fires were sparked by a vehicle with an unsecured chain dragging behind it.

# RUSD transformational changes discussed at board meeting

RUSD Superintendent Jeremi Brewer opened a work session meeting of the Ray Governing Board to a packed cafeteria of community members, parents, and students of the district. The work session was an informational session to give the board and the community a full explanation of the new changes being implemented at the Ray Schools. The new instructional model will be utilizing Khan Academy that is a Artificial Intelligence tool used across education systems to help students to attain the required skills, then followed by project-based learning to emphasize provide additional instruction to those basic skills.

Brewer also explained the attendance is down by 17% across the district which greatly impacts the school's budget and currently the school district is not performing academically. He further explained the administration's plan to increase the enrollment to 800 students and improve the academic attainment.

Discussion also followed on the pending reduction in force that the administration is proposing for the upcoming school year. He explained that at the time of the meeting he had already received about a dozen resignations and retirement notices from staff. The original discussion of RIF's began at the board's monthly meeting on March 20, 2025. Board minutes explain that "We will do everything we can to preserve every possible position that we have but the District will need to be prepared for consolidation and a reduction in force. He stated while our balance sheet may be healthy today, given Ray's trend on student enrollment it might not be in the future". During that meeting he also asked the board for a \$2,500 budget for marketing. That budget was approved on a 3-2 vote. Board Vice President Tino Flores and board member Davila voted no on the budget. The board also voted to hire new pre-paid legal council with Udall and Shumway. This was also approved on 3-2 vote with Flores and Davila voting no on the changes. During the discussion on this Flores asked why the board needed to change the pre-paid legal services. The work session and special board meeting that was scheduled a week later on Thursday, March 27, began at 6 p.m. with the presentation and public questions, which lasted until 7:45 p.m. Initially, it was not planned to allow for public questions and only for the board to interact with the administration, but Board President Amanda Kenney allowed the questions from the public. Parents requesting to know more about how the curriculum delivery changes would affect graduation requirements and the college entry requirements. Some were concerned that it might be too much computer time.

The board agenda for a meeting start of 7 p.m. did not list all the employees that would be discussed; this meeting began at 7:45 p.m. and was adjourned at 8:03 p.m. Several employees that were notified that they were

going to be discussed in the executive session posted on the agenda spoke about their concerns. It was not clear by their comments if they were notified 24 hours prior the start of the meeting, other than comments that they received their notice "last night". Those speaking about being noticed they would be discussed in executive session were:

Lisa Warren who explained that she thought this was not going to be discussed until the April meeting and was not prepared to give a statement. She stated that she was onboard about the project-based learning but she asked if anyone saw a plan for a teacher in the plan. She explained that this plan is 100% Khan Academy. She also expressed that teachers have been demoralized and devalued and she would not be back next year.

Margie Casillas also spoke in the board meeting, another staff member who was noticed she would be discussed. "I want to mirror what Mrs. Warren is saying." She further explained that she was injured in October and when she returned after six weeks, it was chaos. "I have felt demoralized and abused." Casillas has been with the district for 26 years.

Valerie Kelley explained that she worked for the district for over 35 years. She shared that she has already notified the administration that she planned to retire in May and would notify them with an official resignation. She shared the chaos in the CTE department and that she has been fixing problems since December.

Matthew Flores, who was one of the teachers on the executive session list, opted not to speak but his wife Mrs. Boyd Flores interjected to the board that the Arizona Revised Statute notification about the executive session did not specify why they were being discussed. "For all we know, he is being promoted to a principal or being fired," she exclaimed.

Dr. Brewer explained that having an executive session is the only way for the board to discuss staffing together as an elected body and he is required to let the staff that will be discussed know. After the staff that opted not to be discussed in executive session, the board voted unanimously not to enter into executive session (secret session) and table the discussion to a future meeting.

Since this public meeting, the RUSD has increased public outreach on the changes at the district giving further information on the new curriculum deployment. They have also scheduled additional public work sessions. Dr. Brewer encouraged everyone to with questions to contact him.



# Endangered desert pupfish return to Ayer Lake at Boyce Thompson Arboretum; restored lake is once again a safe haven for the rare desert fish

Arizona Game and Fish Department (AZGFD) biologists successfully stocked more than 450 desert pupfish into Ayer Lake on March 26, marking an important return for these endangered fish to Boyce Thompson Arboretum.

"The Boyce Thompson Arboretum is excited to partner with Arizona Game and Fish on conserving the endangered desert pupfish," said Kim Gray, executive director of Boyce Thompson Arboretum. "This species is an important part of the ecosystem and our lake provides the perfect habitat for them."

Ayer Lake, which has been an important refuge site for endangered native fish for decades, needed to be drained over a year ago for essential dam repairs.

"The fish were removed, and we placed them in a pool and fish tank in our greenhouse for safekeeping," said Gray. "They have been very happy and have even produced offspring."

Pupfish collected from two other refuge sites — Cottonwood Tank at Robbins Butte Wildlife Area and the Phoenix Zoo Aviary pond — joined the Boyce Thompson fish in their new lake home.

"I'm really excited to get these endangered desert pupfish back into Ayer Lake," said Brett Montgomery, AZGFD topminnow and pupfish specialist. "It's such a nice habitat where the fish will really have the chance to thrive."

Superior Mayor Mila Besich lent a hand getting the pupfish back into the lake by grabbing a net and helping

stock some of these tiny desert fish.

"The release of the pupfish into Ayer Lake was an experience I will not forget," said Mayor Besich. "We are proud of the important role that the Arboretum plays in sustainability and appreciate the role of Arizona Game and Fish in protecting and preserving habitats for our wildlife."

Ayer Lake provides important habitat for these endangered desert dwellers, and in return, the pupfish bring some benefits of their own to the arboretum.

"Desert pupfish eat aquatic invertebrate larvae, so they can help keep the mosquito population down and they also help control aquatic vegetation," said Montgomery. "Plus they're just really cool fish that are beautiful to look at and fun to watch."

To have this endangered species at Boyce Thompson, the arboretum entered into a Safe Harbor Agreement (SHA) with AZGFD and the U.S. Fish and Wildlife Service. The SHA outlines responsibilities for protecting the pupfish, such as creating replicate populations, minimizing the stocking of mosquitofish and other nonindigenous species, and educating the public about the threats faced by Arizona's endangered native fish populations.

It's also critical that the public never release unwanted aquatic pets or attempt to move fish into this or any other body of water.

"Introducing a non-native species to this lake could mean we have to start this entire process over," said



Montgomery, "instead of moving on to the next phase of endangered fish recovery here at Boyce Thompson."

AZGFD plans to add endangered Gila topminnow to Ayer Lake as well, once the pupfish have had time to adjust

"The arboretum has abundant wildlife and we actively curate our garden spaces to accommodate the various species that make their home here," said Gray. "We're excited to expand our partnership with AZGFD in the future."

Desert pupfish are small (usually less than three inches in length) and are silvery gray with the females displaying dark markings on their sides. During breeding season, males turn bright blue with yellow tails and aggressively defend their territory. Desert pupfish are evolutionarily suited to harsh climates, able to tolerate both extremely hot and cold temperatures, as well as low oxygen, high-salinity water.


