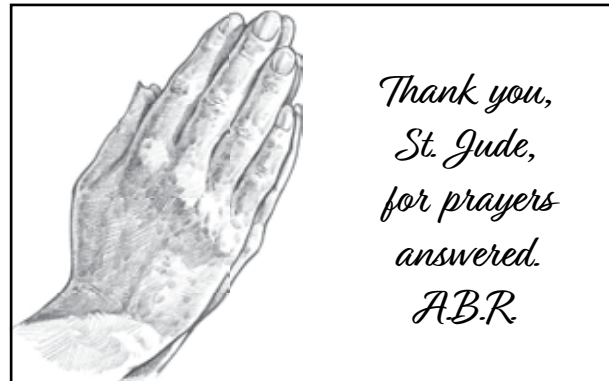

Summers and post-retirement for Don were spent on the road in his van excelling in golf tournaments, bagging trophies and good times. 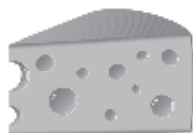

A week of fire! Simmons Fire under containment

On Tuesday, May 28, a fire got started near the community of Riverside, roughly 4.5 miles northwest of Kearny. The fire quickly burned through dry brush, trees and organic matter, destroying four primary structures with it as the fire blazed through the area; five other structures were damaged. It was announced that the fire was human caused but further details have not been released.

The community of Riverside was forced to evacuate

their homes and remained on GO status through Friday afternoon. The area north of Kearny was put on a SET order, which means residents may have to evacuate. The fire was contained in a way that those residents were not forced to evacuate and everyone was placed back to a ready status.

Cooler nights and calm winds help to tamp down the fire during the overnights. A type three wild land fire crew

from Nevada was dispatched to the fire and with the help of hand crews, and aerial fire fighting, they were able to gain ground on the fire.

At press time, the fire consumed 351 acres and is 85% contained with no new growth being reported. The Type Three team was released from the fire and the Arizona Department of Forestry and Fire Management have regained command of the fire.

Ray District High School names baseball field in honor of former Coach Gerry Peters

The Bearcat Community recently gathered to recognize and honor the contributions of one good man to generations of student athletes.

The Ray District High School baseball park is now to be known, forevermore, as the "Coach Gerry Peters Field."

Coach D. G. (Gerry) Peters began his career as an educator in 1963 and did so at Ray High School. Academically, he taught the art of mechanical design and drafting (the discipline of pencil, pen and ink; long before the computer) as well as skills in building treasure from wood. Many of his students still have projects of long ago lovingly created for family. Skill taught in the classroom went on to serve his students well in their efforts to make things better.

Coach Peters' dedication to education and athletics is a

testament to champions on and off the field. Beginning in 1963 and continuing for 32 years; Coach Peters served as Head Varsity Baseball Coach for a record of 216 wins, 112 losses, 3 Division Championships and 3 Arizona State Championships (1967, 1979 and 1981). Under his leadership, 33 Bearcat athletes were chosen for all-state teams and Coach Peters was selected as Baseball Coach of the Year in 1967, 1968, 1969 and 1975.

Throughout his career, Coach Peters designed and constructed training equipment and facilities to develop champions. His batting cages, pitching machine adaptations, batting equipment and regimen, to include designing and building the majority of the equipment for the Ray High Weight Room, created a legacy of excellence and winning.

In addition, as a member of the Elks Club, Coach Peters organized the first Pitch, Hit and Throw competition for the families of Kearny. His dedication to his students

went further in above and beyond; as some went off to serve the country as soldiers under arms at war, Gerry Peters assisted in looking after their family needs at home.

I for one can testify of his love and commitment to looking after my father's pain with Post Traumatic Suffering of World War II and worry as I engaged in Vietnam. Gerry's fidelity took much time, and all during his efforts with building championships for RHS; continuing 14 years until my father's passing.

On April 22, 2024, several of Coach Peters' initial student athletes were present to enjoy the long overdue recognition of this fine man. His commitment to community and developing future generations stands worthy of respect and as example to follow.
