we have endeavored to address and remove or minimize the challenges that have confronted our community over the years

We also have exercised great patience in building relationships, advancing plans, seeking funding for many of our important community projects while also working very vigorously to lay the groundwork to create and capitalize on new opportunities that will benefit all of our residents those who are here today and those who will inevitably come in the future.

Because of our patient but keenly focused determination to greatly improve our town's financial position, I am pleased to report that the Town Council completed our 2024-25 Budget process on schedule and as we approved our annual tax levy, we are proud to have decreased the property tax rate to 5.2%. In 2016, when we started this journey, our property tax rate was over seven percent. Our investments in infrastructure, tackling blight and facilitating significant economic investments all contributed to being able to reduce that rate!

During the month of July, we received a series of "Amazing Announcements" and I am excited to share many of these details with you.

Queen Creek Watershed Plan - The Bureau of Reclamation announced that the Upper Queen Creek Water Restoration plan was funded for the next watershed study. This funding will allow our Upper Queen Creek Watershed group to further study the watershed and develop additional strategies to improve the water flow in Queen Creek and improve our watershed. Once completed, these studies will augment and support the work of the original Queen Creek restoration plan of the late 1990's. There are many partners involved in this planning, including the University of Arizona, Rebuild Superior, Inc., Resolution Copper, Regenerating Sonora and Eastern Pinal & Gila Watershed Group. I am thankful

for all of the partners who have come together to bring this plans to fruition.

Mineral Withdrawal of Land Exchange Properties: For over a decade residents of Superior and the greater Copper Corridor area have discussed the Southeast Arizona Land Exchange and Conservation Act, otherwise known as the Resolution Copper land exchange. When that bill was added to the National Defense Authorization Act of 2014, that bill allowed the Town of Superior to purchase 546 acres of U.S. Forest Service land from the Federal Government. As we began the planning and preparations for the purchase of these lands, we learned that there were plans for mining exploration on the lands which were allocated to Superior for purchase. We worked alongside our Arizona Congressional Delegation, with great support from Rep. Gosar and former Representatives Ann Kirkpatrick and Tom O'Halleran, to have the mineral claims withdrawn from the lands. This week, the BLM announced that the mineral withdrawal has been officially recorded in the Federal Register.

This is one of the several significant steps that had to be completed to begin the official purchase of the lands. We are awaiting the final appraisal of the land from the U.S. Forest Service and appropriate agencies on easements. When that is complete, we will purchase these lands, which will help us to expand our industrial park for job creation, expand our airport for additional economic development as well as expand affordable housing opportunities in Superior. With financial support agreements from Resolution Copper, we will make the purchase and through the Regional Economic Development Agreement, we are currently developing an updated Superior Strategic Plan that will lead us into the future. While all of this seems very immediate, this is where that virtue of patience comes into play, as there are



Safety drives highway closures during wildfire season

PHOENIX – It's summer in Arizona and with that comes blistering heat and wildfires that can cause travelers delays when there's an unplanned highway closure.

During these highway closures, the Arizona Department of Transportation sometimes receives questions on social media that ask a variation of: The wildfire isn't near the highway so why is the road closed?

ADOT and the Arizona Department of Forestry and

Fire Management want people to know that the answer is safety — for the traveling public and first responders.

When a brush fire ignites, there are a few reasons for a full highway closure or for lane restrictions to be implemented.

Brush fires can be fast moving and with multiple agencies responding, it can take time to figure out who needs to go where and establish where the fire is spreading. In some instances, the highway will be shut down briefly to allow crews and firefighters the space to assess the situation and position people where they need to be to fight the fire.

"We try to keep the closures as short as possible and give the traveling public at least a lane," Brett Rupp, an ADOT highway maintenance supervisor in Payson, said. "But depending on the size or location of the fire, it's not safe for vehicles to travel past a fire. We do what is safest for everybody who is out there, from the boots on the ground to the traveling public."

Wildland firefighters sometimes must park their trucks and vehicles on the highway to do their job effectively, which may necessitate a lane closure for an extended period of time. Helicopters carrying hundreds of gallons of water to dump on the fires may also stage on the highway itself because it's a convenient location for operators to set up a portable dip tank to replenish water quickly and head back out.

Low-flying aircraft dropping retardant is also a safety issue for those on the ground, including motorists.

"Those aircraft fly so low it's a safety concern. They're trying to get as low as possible to drop the retardant, and they don't want to impact the traffic. There's always a risk you take with flying aircraft, and we don't want to put the public and drivers in harm's way," Tiffany Davila,

We can all do our part to help reduce the chances of igniting wildfires while driving (and the delays associated with it) by doing the following:

- · Avoid parking your vehicle on dry grass or driving through tall grass because heat from the underside of your vehicle can start a fire.
- · Never throw a lit cigarette out of a vehicle.
- Make sure trailer chains are securely attached. Loose chains can drag on the pavement, shooting sparks off the road and

into dry brush and grass. • Check tire pressure before you travel. Exposed wheel rims can cause

sparks on the asphalt.

ADOT wants to make sure that drivers are prepared when they head out on road trips, and unexpected delays, like wildfires, can add extra travel time. Make sure you pack an emergency travel kit that includes plenty of extra water, healthy snacks, sun protection — such as sunscreen, sunglasses or a hat — a fully charged cell phone and any prescription medication.

Be patient and be prepared. If you are waiting in a backup on a highway that is closed (whether it's for a brush fire, a crash or other active incident) stay in your lane and do not exit your vehicle. Do not drive onto the shoulders of the highway as first responders use that lane.

"Give crews room to get by," Rupp said. "The sooner we can get to the incident scene, the sooner responders can do the work that needs to be done and open the highway safely for everyone."
