- 16 corn tortillas, warmed
- 4 cups shredded Monterey Jack cheese
- Chopped fresh cilantro
- · Fresh lime wedges

Instructions:

- 1. Place beef and Cooking Sauce in electric multifunction cooker. Close lid. Set valve to seal.

Sprinkle with cilantro, drizzle lightly with lime juice and fold tortilla in half to enclose filling. Cook just until browned on both sides. Repeat with remaining filling.
- 5. Serve with additional lime wedges and remaining sauce for dipping.



Drinking Water Sources
The sources of drinking water (both tap and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals, and in some cases, radioactive material, and can pickup substances resulting from the presence of animals or from human activity.

In order to ensure that tap water is safe to drink, EPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide the same protection for public health.
