Wood Fire consumes 7,000 acres

A microburst with lightning moving through the Superior area on Saturday started a forest fire in the Tonto National Forest. The nature-caused Wood Fire consumed over 7,000 acres of Tonto National Forest, mostly within the burn scar of the 2021 Telegraph Fire. The fire was a slow moving fire and did not scorch the earth, which is not expected to create any major flooding risks to the area.

The fire reached the guard rails on the southbound side of Highway 177 which causes some traffic delays due to lane closures. Crews from the Tonto National Forest conducted back burn exercises to ensure the fire would not reach any values at risk, but would allow the fire to burn low lying grasses.

A vehicle fire on highway 177 posed another fire risk to the area. The Superior Fire department responded to the incident and with help from crews working on the Wood Fire, there was not additional fire risks to the area.

The Arizona Trail Alamo Canyon to Picket Post segment has been closed. The forest closure also extends to other areas south of Superior and Forest Road 230. The forest is expected to reopen in a few weeks once the land has had a chance to adjust to the nature-caused fire.

At press time, the fire was about 20 percent contained and is expected to continue to burn to the south and west of Superior in remote and rugged terrain. Residents and travelers in the area may still see some smoke and flames.





Fresenius Dialysis Center in Mammoth closed permanently

Copper Corridor residents who are patients at Fresenius Kidney Care Dialysis Center in Mammoth were shocked when the facility was unexpectedly shuttered in July.

Local readers contacted staff at Copper Area News, explaining how this sudden closure is affecting them. In addition to needing these important treatments, patients must now add a significant drive time into Tucson or Globe to receive their treatments. This is also creating additional financial hardships with the addition of wear and tear on vehicles and commuting costs.

Dialysis is a life saving procedure that many need on a regular basis, a treatment that cannot be skipped or reduced. This closure has added many more expenses and consumed more time for those patients now needing to travel out of the area for these important treatments.

A press release from the company stated:

"After discovering that our Fresenius Kidney Care dialysis facility in Mammoth, Arizona was in need of unexpected equipment repairs, we made the difficult decision to permanently close the facility, which has been temporarily closed since July 16, 2024.

"We understand this creates an inconvenience for some of our patients, and since July, we have been working closely with all our patients to provide updates and arrange for alternate care options in the area for patients to receive dialysis treatments.

"Nurses and Patient Care Technicians will be reassigned to the Tangerine Crossing Fresenius Kidney Care facility, where they can stay with their patients who choose to treat at that location and continue to provide coordinated care alongside the same team of physicians and nurse practitioners."

State invests \$2.4 million in nonprofit arts and culture sector

A one-time investment of \$2 million in support of Arizona's arts and culture sector is reaching communities throughout the state with today's announcement of grants awarded to nonprofit organizations, festivals, and arts learning programs.

On Sept. 5, 2024, the Arizona Commission on the Arts, an agency of the State of Arizona, announced 369 grant awards totaling \$2,403,110. Grants were awarded to a diverse array of organizations and programs, from world-class museums to rural arts centers, and spread across the state from Flagstaff's annual Hopi Art and Culture Festival to Border Fashion Week in Nogales.

"The arts are an essential expression of Arizona's

vibrant communities and diverse cultures," said Christina You-sun Park, Executive Director of the Arizona Commission on the Arts. "Through the Arts Commission the State invests in a thriving statewide nonprofit arts sector that drives local economies, contributes to the vibrance and livability of our communities, enhances the education of our young people, and promotes the health and well-being of our residents."

Grants were awarded in four categories:

Creative Capacity Grants provide general operating support to arts and culture organizations of all sizes whose primary mission is to produce, present, teach or serve the arts.

This year, 276 organizations were awarded Creative Capacity Grants in amounts ranging from \$880 to \$22,200. Award amounts are based on the organization's size and their application's performance in the competitive review process.

Festival Grants support organizations in their efforts to provide quality arts and cultural programming through community festival activities. Grant awards range from \$2,500 - \$5,000.

Sixty-two arts festivals received grants in this round of funding.

SECTION I: ZONING CODE

ARTICLE V, SECTION 5.1, PERMITTED USES

Section 5.1 PERMITTED USES
A. Permitted uses in the AR, RR, ER, SR, RI-8, and RI-5 Single Family Residential Zone Districts shall be only those uses listed as permitted by-right within the respective zone district. Permitted uses are subject to all other applicable standards of this Ordinance.

1. Non-commercial keeping of fowl subject to the following criteria and restrictions:

a. Number of chickers limited to not more than six (6) per lot.

b. Location of containment areas must be within the rear or side vard of the lot.

 c. Roosters shall be prohibited.

d. The enclosure for fowl must be at lest fifteen feet from a neighboring property and the size of such enclosure shall not exceed two hundred (200) square feet. The height of the enclosure shall not exceed eight (8) feet, or the height of the fence line

(whichever is shorter).
e. The enclosure for fowl shall be maintained and manure picked up and disposed of or composted at least twice weekly. If manure is to be composted, the compost shall be maintained in such a manner that prevents the migration of insects.

f. Water sources for fowl shall be provided with adequate overflow drainage.

g. Feed shall be stored in insect-proof and rodent-proof containers.
 h. Fowl shall not run at-large, outside of the confines of the property.
 B. Additional uses in the AR, RR and ER Zone Districts.

Keeping of fowl subject to the following criteria and restrictions:
 a. Number of chickens limited to not more than six (6) per ½ acre.

SECTION II: TOWN CODE

7-1-13 AREAS ZONED FOR LIVESTOCK- CONDITIONS Section 7-1-13 Areas Zoned for Livestock-Conditions

A. Where otherwise lawful within certain zoning districts as provided in this Code to keep livestock, fowl, or rodents, the land on which said animals are kept or maintained shall not be less than one (1) acre and the authorization to keep and maintain said animals

shall be specifically conditioned upon full compliance with the following:

2. No fewir, rodents, or livestock shall be ecoped; stabled, or confined in any building within one hundred (100) feet from any residence, dining, or sleeping quarters which may be situated on adjacent land and all such animals shall be kept in suitable enclosures and shall not be permitted to run at large. All such enclosures shall be maintained at all
